## Terms and Conditions. (For family members, substitute 'I' with 'we', 'my' with 'our' etc)

**1. Members are responsible for their own safety.** I recognise that windsurfing is an activity in which there is a risk of personal injury or death. I am aware of and accept these risks, take responsibility for my own health, safety, actions and involvement, and accept that HWC cannot be responsible for members' (or their guests) safety. I understand HWC do not offer any safety cover, and that members are responsible for making the decision to sail based on their own assessment of their (and family members) health, abilities and the prevailing weather conditions. I confirm I have read: the club's Risk Assessment for Hickling Broad, Safety Summary, and will abide by the Club's Safety policy, and the Club 'Code of Conduct.' (\*\*Refer below)

**2. Data Protection.** I consent to my personal contact data being stored and processed by HWC so that the Club can contact me to advise: Club events, safety updates, an emergency, Club news, and membership renewal reminders.  
Photography: Group photographs of Members (Adults, and Children) may be used for Club news letters, Club electronic media e.g. Web site, and Club controlled social media. I consent to being included in such photography unless I specifically "opt out" when signing in to an event itself. Single images of children will never be published without written parental or guardian consent. I confirm I have read the Club's Data Protection Policy.

**3. Child protection.** I confirm I have read, understood, and will abide by the HWC's Child Protection Policy.
